#### **CURRICULUM UPDATES**

#### <u>Update on Academic Content Standards Revision</u>

During the second week of November, the first drafts of Ohio's revised content standards for Mathematics, Science, English Language Arts and Social Studies will be available on the Ohio Department of Education's Web site for review. Please remember they are **DRAFT** documents, so your feedback continues to be critical to the process.

This work has been informed by legislation (House Bill I), findings from international benchmarking, expert critiques and studies from national organizations, models from learned societies in each content area, and input from educators across Ohio.

As you review the proposed revisions, please focus on the framework and content of the standards, the user friendliness of the document and implications for curriculum, instruction and assessment.

Designed to be Web-based, the standards will be supported by model curricula which will include content statements, instructional strategies and links to instructional resources. Educators are not expected to implement the standards until the standards and model curriculum have been developed and new assessments have been designed. (We anticipate a three-year window for all work to be completed.)

We encourage educators across the state to participate in discussion groups and professional conversations around the standards. We intend to provide a Webcast and a toolkit as resources to support these discussions. Look for an announcement for the date of the Webcast to come soon.

Reviewers will have the opportunity to provide feedback electronically individually or collectively as a reviewing group. Content area organizations also will be host focus groups to foster these conversations and facilitate feedback.

An important reminder – the timeline for this process continues as follows:

Nov – Dec 2009	Posting of the drafts, focus groups, online feedback
Jan – Mar 2010	More editing and revision as a result of the feedback
Apr – June 2010	The State Board of Education resolution and adoption process
June 2010 – Mar 2011	Creation and vetting of model curricula, accompanying instructional strategies and pertinent resources
Mar 2011 – TBA (2012-2013?)	Test item development, field testing and adoption of a new assessment system

Given the timeline, it becomes important that we all pace ourselves throughout this process. It will be more of a distance race than a sprint, with quality of content and practicality for educators high on our priority list. We hope you will join us in creating documents that will guide and promote a high level of teaching and rigorous degree of learning in our state.

# Physical Education Academic Content Standards Training Workshops to be held in November

# Math Science Partnership (MSP) Grants

Schools identified as high or medium support by ODE will have the opportunity to apply for the latest round of MSP grants. Schools will partner with STEM university faculty and Educational Service Centers (ESCs) to improve the teaching and learning of science and/or mathematics at each school. Partners will research and identify the specific needs of the individual school and work towards increasing the mathematics and/or science content knowledge of the teachers, developing systems of support for teachers and creating real change in the classroom.

The goals for this project are:

- to improve student achievement in mathematics and science;
- to increase teacher content knowledge in mathematics and science;
- to develop successful programs that can be used with other schools and partners; and
- to improve connections to the real world in the classroom (relevancy, inquiry and problem-solving skills).

#### **ASSESSMENT UPDATES**

#### Reminder of the Impact of HB 1 on ODE Assessments for the 2009-10 school year

- The Ohio Achievement Tests (OAT) have been renamed the Ohio Achievement Assessments (OAA).
   The content of the tests has not changed. The change in name will begin with the Spring 2010
   Achievement Assessments.
- Grades 4 and 7 writing and grades 5 and 8 social studies assessments are suspended for two years.
- OGT items will not be subject to public release beginning with the Spring 2010 OGT administration. As a result, new item-analysis reports will be discontinued.

The bill also calls for development of a new assessment system to replace the current Ohio Graduation Tests with a three-part assessment system:

- 1. Nationally standardized assessment (science, mathematics and English language arts);
- 2. Series of end-of-course exams (science, mathematics, English language arts and social studies); and
- 3. Senior project (student or group of students, assess chosen content and skills).

These three parts will be used to comprise a composite score for graduation. The Department is working on the details and a timeline for this transition to take place. For the current year (2009-2010), there is no change to the OGT assessment schedule.

Please continue to monitor the ODE Web site and future editions of the *Ides of ODE* for additional information about these and other changes as details become available.

#### Clarification on Diagnostic Assessment Availability

Diagnostic Assessments are available on the ODE Web site. As a cost-savings measure, ODE will no longer print additional Diagnostic Kits. However, ODE has Diagnostic Kits for *new buildings* and *new classrooms* and will continue to distribute kits while current supplies last. Those districts that have **already received** the kits **will not receive duplicate kits**. The manipulatives in the kit will not be replaced, but districts may purchase them at teacher stores or wherever available.

#### Ohio Statewide Assessment Program Rules Book for 2009-10

The Ohio Statewide Assessment Program Rules Book was posted to the ODE Web site on September 29, 2009. The Rules Book has been revised and is in a new format (no longer a question/answer format) with grouping of topics under headings to facilitate use. If there are changes or edits to the rules book during the school year, a change page will be posted on the ODE Rules Book Web page.

#### **Updated Power Point Presentations**

In past years, ODE has posted the PowerPoint presentations from the fall regional meetings on the ODE Web site under professional development. ODE is in the process of updating the PowerPoint presentations from last year's regional meetings and will be posting updated versions to the ODE Web site by the end of October. The PowerPoint presentations will update changes to the assessment program and include important dates and contact information.

### Alternate Assessment for Students with Disabilities (AASWD)

District test coordinators will enter enrollments and submit Pre-ID files through TIDE November 2-December 4 for both the OAA and OGT AASWD. Binder kits will be sent to districts the week of January 11. AASWD Administration Manuals have been posted on ODE's Web site at <a href="education.ohio.gov">education.ohio.gov</a>, keyword search: alternate assessments. Educators wishing to receive training on administering the AASWD should contact their region's State Support Team.

# **NAEP Updates**

The National Assessment of Educational Progress (NAEP) 2009 state and national results for grades four and eight mathematics was released on October 14. Ohio schools chosen for NAEP 2010, which will yield national results only, have been notified of their selection. NAEP 2010 assessments will run from January 25 through March 5, 2010.

NAEP, often referred to as The Nation's Report Card, is the only nationally representative and continuous assessment of what students across the country know and are able to do in various subjects. In 2010, there will be operational and computer-based tests, as well as some pilots.

Some schools at grade four, eight and 12 will be taking paper-pencil tests (operational) in U.S. history, civics and geography. In addition, grade four students will be assessed in mathematics and writing, and grade eight students will be assessed in mathematics.

Some schools will participate in a computer-based writing pilot at grades eight and 12.

#### 374 Students Earn Diplomas Employing the Alternative Pathway

Statewide, 374 students who graduated in the class of 2009 earned a diploma by employing the alternative pathway. Under Ohio Revised Code (ORC) §3313.615, students can graduate by passing four of the five OGT <u>if</u> they meet <u>all</u> of the criteria for the alternative pathway. #### Requests for Exception to 1% Cap on Alternate Assessments

The U.S. Department of Education (USDOE) has restricted Ohio to limit the count of proficient or higher scores on the alternate assessment to 1 percent of its statewide tested population. This means that for the 2009-2010 school year and beyond, most LEAs will be restricted to this cap.

Unless otherwise directed by the USDOE, ODE's Office of Accountability plans to accept requests for exception to the cap only from LEAs with special circumstances (i.e., those having a small tested population of approximately 1,000 tested students and those that draw a disproportionate number of families of students with

the most severe cognitive disabilities). However, under the current restriction, there is no guarantee even these LEAs will receive their requested number of students.

To assist LEAs that are using the alternate assessment for greater than 1 percent of their total tested student population, Ohio will continue to work with the USDOE to explore potential flexibility in the federal restrictions. Based on past requests for flexibility, it is unlikely that the USDOE will grant any state exceptions to the cap.

To clarify, the restriction is on the count of proficient or higher scores on the alternate assessment that can be used for accountability purposes. The restriction is not on the number of alternate assessments that can be administered. Once an LEA exceeds the cap on the scores that can be used for accountability purposes, the remaining scores will be reassigned (i.e., changed from proficient, accelerated or advanced to basic). A random process identifies which scores will be reassigned at the district level and the reassigned scores then will be attributed to the building the student attends.

#### Social Studies standards revision moves forward

Am. Sub. H.B. 1 requires revision of Ohio's academic content standards in social studies and other subjects by June 30, 2010.

Proposed revisions include reduced breadth, increased depth and the combination of process and content standards. The number of standards will decrease to four: government, economics, geography and history. Benchmarks and grade-level indicators are being replaced with themes, topics and content statements.

Strong instruction in the social studies throughout grades K-12 will ensure a sound transition from one set of standards to the next and prepare students for future state assessments. More importantly, with a strong social studies background, today's students are more apt to be successful in tomorrow's global workforce.

# Health Education Curriculum Analysis Tool (HECAT)

The Health Education Curriculum Analysis Tool (HECAT) can help school districts, schools and others conduct a clear, complete and consistent analysis of health education curricula based on the National Health Education Standards and CDC's Characteristics of Effective Health Education Curricula. The HECAT results can help schools select or develop appropriate and effective health education curricula and improve the delivery of health education. The HECAT can be customized to meet local community needs and conform to the curriculum requirements of the state or school district. Through this training, participants will learn how to identify gaps in current curricula and select or develop appropriate and effective health education curricula based on the needs of the students and improve the delivery of health education.

#### School Health Index (SHI)

The School Health Index (SHI) is a self-assessment and planning guide developed by the Centers for Disease Control and Prevention (CDC) that enables schools to:

- Identify the strengths and weaknesses of their school health promotion policies and programs;
- Develop an action plan for improving student health; and
- Involve teachers, parents, students and the community in improving school policies, programs and services.

Promoting healthy and safe behaviors among students is an important part of the fundamental mission of schools, which is to provide young people with the knowledge and skills they need to become healthy and productive adults. Improving student health and safety can:

- Increase students' capacity to learn:
- · Reduce absenteeism; and
- Improve physical fitness and mental alertness.

Through this training, participants will be introduced to model policies and practices derived from CDC's research-based guidelines for school health programs and practices that are deemed most effective in improving youth health-risk behaviors.

#### Making the Global Connection: Linking Students and China in the 21<sup>st</sup> Century

ODE's Office of Curriculum and Instruction, The Ohio State University K-12 Chinese Flagship Program, and the Ohio Association of Teachers of Chinese (OATC) are pleased to announce the fourth annual symposium for district and school decision-makers and Chinese language teachers interested in developing, expanding or sustaining Mandarin Chinese language programs.

The event will take place on Tuesday, December 15, 2009. It will be held in Columbus on the campus of The Ohio State University in the Mendenhall Laboratory Building (building #054 on the OSU campus map), located at 125 S. Oval Mall, Columbus, OH 43210. Registration will begin at 8:30 a.m. next door in the lobby of Hagerty Hall (building #037), located at 1775 College Rd., Columbus, OH 43210. The symposium will begin promptly at 9 a.m. and will conclude at 2 p.m.

The event will begin with a short plenary session for all participants. Ellis Yan, CEO of Ohio-based TCP, Inc., will provide the keynote address. His remarks will provide a business perspective on the relationship between Ohio's economy and the study of Chinese language and culture. Afterwards, participants will attend one of three breakout sessions:

 Track A will address the needs of schools seeking information and options for initiating and staffing K-12 Chinese programs. Information about the ODE-College Board Chinese Guest Teacher Program will be provided.

- Track B will address the needs of schools with established Chinese programs. Please note that this
  session has been completely reworked for this year's symposium and will provide new information and
  resource possibilities for those who attend.
- Track C will provide professional development and networking opportunities for classroom teachers of Chinese.

The symposium will conclude with a networking session that will be designed to allow schools and districts to share what they are doing programmatically and what resources they are using.

Superintendents, principals, curriculum coordinators, foreign language coordinators and K-12 Chinese language teachers are all encouraged to attend this event to learn more about Chinese language programming in Ohio.

There is no cost to attend the symposium, although parking will be the responsibility of participants. Please note that light snacks will be available during a brief break between sessions at the noon hour, but a formal break for lunch is not included in this year's program. Participants are welcome to brownbag their own lunches if they wish.
